Category	Examples
Advertising & Marketing	Social media ads, business cards, website hosting
Software & Tools	QuickBooks, Canva Pro, editing software
Legal & Professional Fees	Bookkeeper, CPA, lawyer
Travel	Business trips, hotel stays, parking, tolls
Cost of Goods Sold (COGS)	Inventory
Cost of Labor	Freelancers, VAs, video editors
Meals	Client lunches, coffee meetings
Education & Training	Courses, coaching, conferences
Bank Charges	Stripe fees, PayPal fees, bank late fees
Supplies & Materials	Printer, paper, pens, label maker

Note: If you're unsure whether something qualifies, make a note of it and ask a tax professional before filing.
